

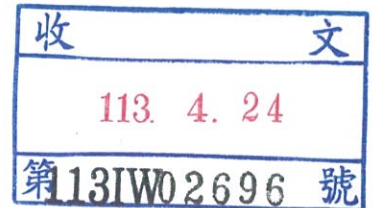

### 徵稿啟事

- 本研討會將評選出「最佳論文獎」，並於閉幕典禮公開頒獎表揚，欲角逐最佳論文獎項者，須以全文投稿。
- 本研討會採匿名審查制，凡接受發表之論文以全文投稿者，將擇優推薦至「中原企管評論」、「產業管理評論」、「Innovation in the Social Sciences」審查。
- 論文審查結果將以 E-mail 通知通訊作者，並同時公告於研討會官網。

#### IMPORTANT DATES

- The conference accepts submissions in the form of "abstracts" or "full papers," submitted manuscripts should be limited to academic papers that have not been formally published.
- All papers must be submitted through the online submission system, and manuscripts are only accepted in Microsoft Word files uploaded to the submission system. The abstract should be no more than 2 pages, and the full paper should be no more than 20 pages. Both Chinese and English writing are acceptable, and adhering to the specified format is important when submitting. Please visit the website to download the abstract/full paper format.
- The "*Best Paper Award*" will be presented at the closing ceremony. Those who want to compete for it must submit the full paper.

- The conference uses a double-blind review system. Accepted papers will be selectively recommended for review in "*Chung Yuan Management Review*," "*Industry Management Review*," and "*Innovation in the Social Sciences*."
- The corresponding author will be notified of the paper review results via email, and the results will also be announced on the website.
- Only abstracts will be published in the conference proceedings.

## REGISTRATION INFORMATION

- Accepted papers must have at least one author complete the registration process and attend the conference to present the paper in either Chinese or English. Details about the presentation requirements and the schedule will be provided separately. Scholars based domestically primarily deliver their presentations in person, whereas international scholars can present their papers either in person or via online meeting.
- Please complete the online registration and payment by June 12, 2024 (Wed) based on the information provided in the acceptance letter email to ensure that your paper can be included in the conference program. (※ Non-CYCU authors can pay on-site during conference registration but registration through the online system is a must.)
- The registration fee includes the conference brochure, name tag, participation in the conference (opening/closing ceremonies, keynote speeches, paper presentation sessions), refreshments, certificate of presentation or participation, and the conference proceedings (PDF).
- The conference only accepts on-site payment for registration fees. Once payment is made, refunds will not be issued. Authors who have completed the payment are required to retain the proof of payment, fill out the information on the registration system, and provide it for verification by the organizers.

- On-site payment can be made at the Corporate Social Responsibility Research Center on the first floor of the College of Business at Chung Yuan Christian University. The center's opening hours are Monday through Friday, 10:00 AM to 4:00 PM.
